Participants will bowl 5 games qualifying, scratch. Each participant will draw for starting lane.

Top 10 scratch scores will advance to match play. Match play will consist of 2 game total pinfall elimination matches to crown the Nebraska Queens Champion.

If the field is fewer than 36 bowlers, we will have fewer finalists.

Nebraska Queens Tournament Rules

1. Date and Location: Sunday, September 27, 2026, 8:30am, Sun Valley Lanes, Lincoln, NE
2. The entry fee is \$85.00. A fee of \$30.00 will be charged for all returned checks.
3. Entries closing date: September 27, 2026 at 8:00am
4. All entrants must hold a current season's USBC and Nebraska USBC membership. Non-USBC members may qualify for entry into the tournament by purchasing an association membership through the tournament director. If you do not hold a NE USBC membership card, you must pay local and state fees.
5. Format of the tournament:
 - Participants will bowl 5 games of qualifying. Each participant will draw for starting lane.
 - Top 10 scratch scores will advance to match play.
 - 1 & 2 get 2 bye, 3-10 will bowl 2 game total pinfall elimination matches.

If the field is less than 36, we will have fewer finalists, and number of byes may change.

6. In the event of tie (s) in the qualifying 5 games or in match play, a 10th frame roll-off will be held to determine the bowler who will advance to the next game.
7. All prize fees collected will be paid back to the winners.
8. Winner will receive a paid entry into the USBC Master's or Queen's plus a portion of the prize fund. The winner will also have the option of a ring or the cash value of the ring selected by the Nebraska USBC.
9. Payout is 1:4. Unless fewer than 36 bowlers.
10. The tournament management will be members of the Nebraska USBC Association Board of Directors and a committee appointed to conduct the tournament.
11. All participants will be eligible to win USBC awards.
12. Youth can bowl, but must have a consent form signed by parents or guardians. All winnings will be put in a SMART account.
13. Entrants are expected to wear suitable attire. Use good judgment when selecting the appropriate attire. Clothing with derogatory, offensive or suggestive language will not be permitted. Examples of prohibited attire include, but are not limited to: hats (medical reason only – request must be in writing), tank tops, short shorts, jeans that are not neat, clean or in good condition. Bowlers will be required to change if attire is deemed inappropriate by tournament management or designee. Tournament management or designee decision will be final.
14. All rules are subject to change to the discretion of the tournament committee.
